Academic Fee Refund Policy AY 2025-26

- 1. Refund Details on Withdrawal of Admission by the candidate:
 - a) If a candidate withdraws his/her admission on or before 30th July 2025, the candidate will receive a 100% refund on the entire Academic fees deposited.
 - b) If a candidate withdraws his/her admission from 31st July to 14th August 2025, the candidate will receive a 90% refund on the Academic fees deposited.
 - c) If a candidate withdraws his/her admission from 15th Aug to 30th Aug 2025, the candidate will receive an 80% refund on the Academic fees deposited.
 - d) If a candidate withdraws his/her admission from 31st Aug 2025 to 14th Sept. 2025, the candidate will receive a 50% refund on the Academic fees deposited.
 - e) If a candidate withdraws his/her admission on or after 15th Sept 2025, zero refund.
